Pursuant to RCW 80.28.060 and Chapter 480-80 WAC, please find enclosed for filing the following proposed revision to the WN U-60, tariff for electric service of Puget Sound Energy (“PSE”):

- 9th Revision of Sheet No. 258 – Electricity Energy Efficiency Program – Large Power User Self-Directed Program
- 9th Revision of Sheet No. 258-A – Electricity Energy Efficiency Program – Large Power User Self-Directed Program (Continued)
- 4th Revision of Sheet No. 258-B – Electricity Energy Efficiency Program – Large Power User Self-Directed Program (Continued)

The purpose of this filing is to update the conservation program Schedule 258 funding period.

PSE’s Conservation Resource Advisory Group (CRAG) also received a draft of the mark-up version in its October 15 presentation, consistent with condition (8)(a) in Attachment A of Order 01 in Docket UE-132043.

The revisions contained in these proposed Schedule 258 tariff sheets are updates of the four-year program timeframe. The current Schedule 258 four-year program funding cycle expires at the end of 2018. The revised program funding cycle allows large power users to participate in the self-directed program from 2019 through 2022.
