Puget Sound Energy ("PSE") hereby submits in connection with Docket UE-200879 the following tariff sheet to replace the tariff sheet that accompanied PSE's October 21, 2020 filing which was submitted under PSE's Advice No. 2020-37. This filing includes the following portion of the Company's WN U-60 tariff for electric service.

WN U-60, Tariff G - (Electric Tariff):

2nd Revision of Sheet No. 141X - Protected-Plus Excess Deferred Income Tax (EDIT) Reversals Rate Adjustment

The purpose of this filing is to provide a substitute tariff sheet reflecting a revision to the description of the Energy Charge for Schedules 7A and 25 in this schedule. This change is being made following discussions with the Commission's Staff.

Additionally, PSE hereby submits in connection with Docket UE-200879 a cover letter to replace the cover letter accompanying PSE's October 21, 2020 filing which was previously submitted under PSE's Advice No. 2020-37. This substitution is being made to correct a typographical error. The original cover later stated that the current monthly credit rate is intended to apply to the Energy Charge for both the first 200,000 kWh and for all kWh over 200,000 kWh. This has been corrected to state that the current monthly credit rate is intended to apply to the Energy Charge for both the first 20,000 kWh and for all kWh over 20,000 kWh.

The tariff sheet described herein reflects an issue date of October 21, 2020, and an effective date of November 20, 2020, as it was originally filed. Posting of the proposed tariff change for public
