You are commanded to appear before the Washington Utilities and Transportation Commission (Commission) at the special proceeding referenced in the attached Order and Notice of Hearing at 9:30 a.m., on November 29, 2021, and to remain there until discharged by the Commission, to give testimony and evidence under oath as to the operations of Jack Chapman, Jr. d/b/a J & T Hauling (J & T Hauling). J & T Hauling, or a representative, shall appear by phone or Zoom at the time set forth above unless the Executive Director and Secretary of the Commission, by separate notice, specifies a different time and place. This is ordered pursuant to the subpoena powers granted in RCW 34.05.446, RCW 80.01.060(1) and RCW 81.04.510.

You are further commanded to bring with you the following documents:

For a company seeking to avoid further enforcement action by ceasing unpermitted operations and leaving the industry, you must bring sufficient documentation or records to demonstrate closure of your unpermitted solid waste transportation business. In the case of those whose entire business involves solid waste transportation, those papers might include documentation from (1) the Secretary of State's office for dissolution of your business; (2) the Department of Revenue for cancellation of your business license; (3) your Internet service provider (or equivalent) showing cancellation of a website or email account; (4) your telephone provider showing cancellation of your corporate telephone number; (5) proof of cancellation of your company advertising; and (6) sales receipts for any company equipment sold in the process of shutting down and closing. For those companies who will continue with a business but only close that portion involving solid waste transportation, similar documentation (*e.g.*, changed website or advertising) will prove most helpful to the presiding officer.

If you choose to produce the subpoenaed documents by mailing them rather than producing them at the proceeding, you must still appear at the proceeding and the subpoenaed documents must be received at the Commission before the proceeding or you will not have complied with this subpoena.
