
The in-state Household Goods Packing Material suppliers are each imposing yet another price increase on HHG packing materials. The cause for the increase is a nationwide increase in cost of linerboard leading to increased cost for corrugated materials. The scheduled date for the increases to take effect are on or after May 24, 2021.

This time the increase for HHG packing containers is 12% from Pioneer Packaging, see attachment; and a range of increase from 11.5% to 15.4% from Victory Packaging, see the following -
