Blue Rock Water Company has filed with the with the Washington Utilities and Transportation Commission ("Commission") to approve 1) adding a water leak procedure (Rule 29) and 2) a water system facilities charge (Schedule 5). The water leak procedure will allow the utility to reduce a customer's water use charge in the event of high-use caused by leak once the customer presents "a bill from a plumber or other evidence the leak has been repaired." The adjustment will not exceed two (2) months and customers are permitted this credit once every twenty-four (24) calendar months.

The water system facilties charges apply to the Lowper Water System (DOH ID# 019595) and Suddenview Water System (DOH ID# 12451F) for <u>new connections that have not paid</u> the Clallam County PUD or Snohomish County PUD general facilities. This is a pass through charge for Blue Rock Water Company.

The commission has the authority to set final rates that may be lower or higher than the company's request, depending on the outcome of its investigation. You can submit comments by going to www.utc.wa.gov and clicking "Submit a Comment," or by one of the following options:
