Newmax, LLC d/b/a Interrmax Networks, hereby submits the following reports in accordance with WAC 480-123-070 & WAC 480-123-080

 <u>Report on use of federal funds and benefits to customers WAC 480-123-070(1)(a):</u> For an ETC that receives support based only on factors other than the ETC's investment and expenses, the report must provide a substantive description of investments made and expenses paid with support from the federal high-cost fund. For ETCs that receive any support based on the ETC's investment and expenses, the report must provide a substantive description of investment and expenses, such as the NECA-1 report, the ETC will report as the basis for support from the federal high-cost fund.

 - (a) The date and time of onset and duration of the outage;
 - (b) A brief description of the outage and its resolution;
 - (c) The particular services affected, including whether a public safety answering point (PSAP) was affected;
 - (d) The geographic areas affected by the outage;
 - (e) Steps taken to prevent a similar situation in the future; and
 - (f) The estimated number of customers affected.

 <u>Report on Failure to Provide Service WAC 480-123-070(3)</u>: ETCs not subject to WAC <u>480-120-439</u> are required to report failures to provide service pursuant to this subsection. The report must include detailed information on the number of requests for service from applicants within its designated service areas that were unfulfilled for the reporting period. The ETC must also describe in detail how it attempted to provide service to those applicants.

4. <u>Report on Complaints per One Thousand Handsets or Lines WAC 480-123-070(4)</u>: The report must provide separate totals for the number of complaints that the ETC's customers made to the Federal Communications Commission, or the consumer protection division of the office of the attorney general of Washington. The report must also generally describe the nature of the complaints and outcome of the carrier's efforts to resolve the complaints.
