The company requests Commission approval to amend its filed Tariff Number 5 on Less than Statutory Notice to include a Special Fuel Surcharge Tariff Supplement to recover the rising cost of fuel. Fuel index prices have increased from \$2.674 per gallon for the base period to \$5.191 per gallon current price. Proposed changes are to add a Special Fuel Surcharge Supplement No.4 in the amount of 4.47%.
