YOU MUST RESPOND WITHIN 15 DAYS OF THIS NOTICE

The Washington Utilities and Transportation Commission (Commission) believes that Lariviere Inc. d/b/a. T. Lariviere Equipment & Excavation (T. Lariviere or Company) violated Revised Code of Washington (RCW) 19.122.055(1)(a) by failing to notify the one-number locate service and caused damage to an underground gas facility.

RCW 19.122.055(1)(a) states, in part, that excavators who fail to notify a one-number locator service and cause damage to an underground gas facility are subject to a civil penalty of not more than \$10,000 for each violation.

Commission staff (Staff) conducted an investigation that included reviewing damage reports, investigation reports, a review of the One Call Center database, and communications with the Company. The documents reviewed identified a natural gas event that involved T. Lariviere damaging a natural gas facility while excavating without a valid locate ticket.

The Commission reviewed findings and recommendations made by Commission staff and hereby notifies you that it is assessing a \$2,500 penalty (Penalty Assessment) against you on the following grounds:

- Alleged Violation:**
On December 28, 2022, T. Lariviere was excavating at 4600 S. Madison Rd., Spokane, Washington. While excavating, T. Lariviere workers struck and damaged an underground Avista Corporation (Avista) natural gas facility. The Damage Information Reporting Tool (DIRT) report submitted by Avista on January 10, 2023, indicated that T. Lariviere was excavating without a valid request to locate underground utilities.

2. **Analysis:**

The alleged violation concerns RCW 19.122.055(1)(a), which states, in part, that an excavator must contact the one-number locate center before beginning excavation. On December 28, 2022, T. Lariviere severed an Avista 2-inch natural gas main line. The damage reports submitted by Avista state that there was no valid locate ticket for this location. Staff communicated with T. Lariviere, who acknowledged it was the Company's mistake and explained that the Company had no further information to contribute to the investigation. Staff reviewed the One Call Center database and did not find a locate ticket for T. Lariviere at this location.

The Commission considered the following factors in determining the appropriate penalty amount for the violation:

1. **How serious or harmful the violation is to the public.**

This incident could have been significantly more harmful to Company workers, utility technicians, nearby homeowners, and the public, and could have resulted in severe injury and/or loss of property.

2. **Whether the violation is intentional.**

The violation appears to be due to negligence rather than a lack of knowledge of Washington state's dig law. T. Lariviere has called in eight requests to locate over the past 12 months. The Company is aware of the requirement to contact the one-number locate service before beginning excavation.

3. **Whether the company self-reported the violation.**

T. Lariviere did not self-report the violation. The Commission became aware of the violation when Avista filed a DIRT report following the damage incident.

4. **The likelihood of recurrence.**

The likelihood of recurrence depends on the Company's actions going forward and its willingness to notify the one-number locate service before beginning excavation.

5. **The Company's previous violations and penalties.**

- **Warning Letter**

- On March 5, 2020, the Commission mailed an Alleged Violation of Washington Dig Law letter to T. Lariviere. The letter included detailed information about Washington State's underground utility damage prevention act, requirements for submitting utility locate requests before excavating, and the possibility of penalties for each violation. The Commission mailed the letter after receiving a report of damage caused by T. Lariviere on July 24, 2019, that occurred because the Company failed to submit a request to locate underground utilities before excavating.

- **Past Penalty Assessments**

- On November 23, 2021, the Commission issued T. Lariviere a Penalty Assessment of \$1,000 for two violations of RCW 19.122.055(1)(a) – DG-210771.

The Commission has considered these factors and determined that it should penalize T. Lariviere as follows:

- \$2,500 penalty for one violation of RCW 19.122.055(1)(a) with an offer to suspend a \$2,000 portion of the penalty for one year, and then waive it, subject to the conditions that:
 - 1) Company supervisors and field crew responsible for excavation complete Dig Safe Training provided through the National Utility Contractors Association (NUCA) within 90 days of this Penalty Assessment;
 - 2) The Company must submit documentation of that attendance to the Commission within 5 days of attending training; and
 - 3) The Company must not commit any further violations of RCW 19.122 within 12 months of the date of this Penalty Assessment.

These facts, if proven at a hearing and not rebutted or explained, are sufficient to support the Penalty Assessment.

Your penalty is due and payable now. If you believe the violation did not occur, you may deny committing the violation and contest the penalty through evidence presented at a hearing or in writing. Or, if there is a reason for the violation that you believe should excuse you from the penalty, you may ask for mitigation (reduction) of the penalty through evidence presented at a hearing or in writing. The Commission will grant a request for a hearing only if material issues of law or fact require consideration of evidence and resolution in a hearing. Any request to contest the violation or for mitigation of the penalty must include a written statement of the reasons supporting that request. Failure to provide such a statement will result in denial of the request. *See* RCW 81.04.405.

If you properly present your request for a hearing and the Commission grants that request, the Commission will review the evidence supporting your dispute of the violation or application for mitigation in a Brief Adjudicative Proceeding before an administrative law judge. The administrative law judge will consider the evidence and will notify you of their decision.

You must act within 15 days after receiving this Penalty Assessment to do one of the following:

- Pay the \$2,500 penalty amount due; or
- Pay \$500 and notify the Commission that you accept the offer to suspend a \$2,000 portion of the penalty amount subject to the following conditions:
 - T. Lariviere management and the field crew responsible for excavation must complete NUCA Dig Safe Training (<https://utc-9183.quickbase.com/db/bpkt6vndh>) within 90 days of service of this Penalty Assessment; and
 - **The Company must submit documentation of that attendance to the Commission within 5 days of attending training;** and
 - T. Lariviere must not incur any additional violations of RCW 19.122 within 12 months of the date of this Penalty Assessment; or

- Request a hearing to contest the occurrence of the violations; or
- Request mitigation to reduce the amount of the penalty.

I have read and understand RCW 9A.72.020 (printed below), which states that making false statements under oath is a class B felony.  - o The Company must not commit any further violations of RCW 19.122 within twelve (12) months of the date of this Notice.
- [] 3. **Contest the violation.** I believe that the alleged violation did not occur for the reasons I describe below (**if you do not include reasons supporting your contest here, your request will be denied**):
- [] a) I ask for a hearing to present evidence on the information I provide above to an administrative law judge for a decision.
OR [] b) I ask for a Commission decision based solely on the information I provide above.
- [] 4. **Request mitigation.** I admit the violation, but I believe that the penalty should be reduced for the reasons set out below (**if you do not include reasons supporting your application here, your request will be denied**):
- [] a) I ask for a hearing to present evidence on the information I provide above to an administrative law judge for a decision.
OR [] b) I ask for a Commission decision based solely on the information I provide above.
