We are filing a disposal fee only rate increase to revise tariff #17, pages #2, 22, 23, 26, 28, 34, 35, 36, 37

**\* Present provisions are:**  
Tipping fees have been calculated based on the Olympic View Transfer Station rates for disposal of municipal solid waste of \$118.00 per ton effective 01/01/2023.

**\* Proposed changes are:**  
Proposed changes are to incorporate the increased Olympic View Transfer Station rates for disposal of municipal solid waste of \$121.54 per ton effective 01/01/2024.

**\* Explain why the company is proposing this tariff revision:**  
This increase is necessary to offset increased disposal site fees. The rate increase is a direct pass-through from the County to increase disposal rates.

**\* Explain why the Commission should allow this tariff revision to take effect with less than 30 days' notice (45 days' notice for solid waste):**  
We are filing this tariff revision with the required 45 days notice to the Commission, however we are requesting a waiver from customer notice requirements prescribed by RCW 81.28.050 and requesting to provide notice to customers on the first bill as has been commission practice in accordance with WAC 480-70-271.
