Re: TV-240440- Reinstating Temporary Household Goods Permit - THG069611

Dear Sound Moving NW LLC:

On June 10, 2024, Sound Moving NW LLC filed an application with the Washington Utilities and Transportation Commission (Commission) to reinstate its permit to provide residential household goods transportation services in the state of Washington. You have met the initial application requirements by attending Household Goods training on February 17, 2021.

The Commission grants Sound Moving NW LLC's request to reinstate permit THG069611 for household goods carrier authority and approves the application in full. Permit THG069611 issued in the name of Sound Moving NW LLC is enclosed, and the company may operate on a temporary basis.

The Commission will continue to evaluate whether Sound Moving NW LLC qualifies for permanent authority. To qualify for permanent authority, your company must satisfy the following requirements:

- 1. Operate for at least six months.
- 2. Allow the Commission to review your business operations and records. Commission staff will review records and inspect vehicle(s), and you must receive a satisfactory safety rating as a result of that review.
- 3. Complete a criminal background check on each person Sound Moving NW LLC employs or intends to employ. The Commission will not grant permanent authority if any company employee has been convicted of any crime within the past five years involving theft, burglary, assault, sexual misconduct, identity theft, fraud, false statements, or the manufacture, sale, or distribution of a controlled substance. Even if a conviction for any of these offenses is more than five years old, the Commission will not grant permanent authority if it determines that the nature or extent of the crime(s) will likely interfere with the proper operation of a household goods moving company.

- 4. Pay any outstanding monetary penalty or fee owed to the Commission.
- 5. Resolve all consumer complaints pending with the Commission.

Sound Moving NW LLC must continue to comply with state laws, Commission rules, and the provisions of Tariff 15-C. Failure to do so will result in Commission enforcement action, up to and including revocation of the company's permit.
