The above-entitled matter, which is in the nature of a complaint against U S West Communications, was filed on December 29, 1989. Respondent filed its answer on January 23, 1990. The pleadings indicate a dispute exists between the complainant and respondent relating to responsibility for payment of bills submitted by respondent for its services. A more detailed account of the dispute is reflected in the foregoing pleadings, which are available for inspection at the Commission's office, Chandler Plaza Building, 1300 S. Evergreen Park Drive SW, Olympia, Washington. The issue having been joined, it is appropriate that the matters raised in the pleadings be brought on for hearing before the Commission.

The hearing hereinafter set is being held pursuant to Part IV of chapter 34.05 RCW pertaining to Adjudicative Proceedings, including but not limited to RCW 34.05.422, RCW 34.05.440, RCW 34.05.449, and RCW 34.05.452. The Commission has jurisdiction over this matter pursuant to Title 80 RCW under which it regulates the rates, services, and practices of telecommunications companies providing service within the state of Washington. Statutes and rules involved include RCW 80.04.110, 80.36.080 and WAC 480-120-106. In addition to the foregoing, statutes and rules involved include those within chapter 80.36 RCW and chapter 480-120 WAC relating to the charges and practices of telephone companies, and chapter 480-09 WAC. The issues involved are generally stated above and more specifically contained in the pleadings herein.

NOTICE IS HEREBY GIVEN That a hearing for the purpose of receiving the evidence of all parties to the above proceeding will be held commencing at the hour of 9:30 a.m., Thursday, April 12, 1990, at the Commission's Offices, 762 Industry Drive, Building 16, Seattle (Tukwila), Washington.


