The above-entitled matter, which is in the nature of a complaint against U S West Communications, was filed on March 15, 1990. Respondent filed its answer on April 4, 1990. The pleadings indicate a dispute exists between the complainant and respondent relating to services rendered by U S West Communications in connection with Remote Call Forwarding and Dialtone. A more detailed account of the dispute is reflected in the foregoing pleadings, which are available for inspection at the Commission's office, Chandler Plaza Building, 1300 S. Evergreen Park Drive SW, Olympia, Washington. The issue having been joined, it is appropriate that the matters raised in the pleadings be brought on for hearing before the Commission.

The hearing hereinafter set is being held pursuant to Part IV of chapter 34.05 RCW pertaining to adjudicative proceedings, including but not limited to RCW 34.05.422, RCW 34.05.413 and RCW 34.05.419. The Commission has jurisdiction over this matter pursuant to Title 80 RCW under which it regulates the rates, services, and practices of telecommunications companies providing service within the state of Washington. Statutes and rules cited by the respective parties include chapter 480-80 WAC and various statutes in Titles 80 and 81 RCW. In addition to the foregoing, statutes and rules involved include those within chapter 80.36 RCW and chapter 480-120 WAC relating to the charges and practices of telephone companies, and chapter 480-09 WAC. The issues involved are set forth in the pleadings herein.

NOTICE IS HEREBY GIVEN That a hearing for the purpose of receiving the evidence of all parties to the above proceeding will be held commencing at the hour of 9:30 a.m., Thursday, June 14, 1990, in the Commission's Hearing Room, Second Floor, Chandler Plaza Building, 1300 S. Evergreen Park Drive SW, Olympia, Washington.

NOTICE IS FURTHER GIVEN THAT ANY PARTY WHO FAILS TO ATTEND OR PARTICIPATE IN THE HEARING SET HEREIN, OR OTHER STAGE OF THIS PROCEEDING, MAY BE HELD IN DEFAULT IN ACCORDANCE WITH THE TERMS OF RCW 34.05.440.
