On May 23, 1994, Cascade Natural Gas Corporation filed with the Commission under its Advice No. W94-05-03, revisions to its currently effective Tariff WN U-3 designated as Original Sheet No. 580.

In addition, Cascade Natural Gas Corporation filed accounting petitions under Advice Nos. W94-05-02 and W94-05-04, requesting authorization to defer costs associated with the Low Flow Showerhead Program and training and education of building code inspectors, respectively.

It appearing that the filing herein would increase rates for natural gas service rendered by respondent and that the rights and interest of the public might be injuriously affected thereby, the Commission June 22, 1994, entered a Complaint and Order Suspending Tariff Revisions. The Commission also authorized setting the accounting petitions for hearing.

The Commission is now in receipt of a letter dated July 13, 1994, whereby respondent requests that the tariff revision and petitions for accounting treatment filed in these docket be withdrawn. The respondent will expense costs associated with the Commission approved Low Flow Showerhead Program.

FINDINGS

1. It is not contrary to public interest that the Complaint and Order Suspending Tariff Revision in this docket

UG-940707(T) be dismissed and that the revision to the respondent's Tariff WN U-3 be withdrawn.

2. It is not contrary to the public interest that the petitions in Dockets UG-940506(P) and UG-940508(P) be withdrawn.

O R D E R

IT IS THEREFORE ORDERED:

1. That the tariff revisions, filed in this docket UG-940707(T), shall be and the same are hereby withdrawn without prejudice, and the Complaint and Order Suspending Tariff Revisions in this docket dated June 22, 1994, shall be and the same is hereby dismissed.

2. That the petition for accounting treatment, filed in this docket UG-940706(P), shall be and the same are hereby withdrawn.

3. That the petition for accounting treatment, filed in this docket UG-940708(P), shall be and the same are hereby withdrawn.
