**RE: Docket No. UG-950392 – Amendment to Exhibit A**

Dear Mr. Danner:

Enclosed for filing by Puget Sound Energy, Inc. (“PSE”) are three copies of Revision Six to Exhibit A of the special contract agreement between a predecessor company, Washington Natural Gas Company, and the Boeing Company (“Revision Six”). The special contract agreement (the “Contract”) was approved by the Commission under the provisions of WAC 480-80-355 (now WAC 480-80-143) in Docket No. UG-950392.

Revision Six does not make any significant changes to the Contract and is limited to making changes to Exhibit A to the Contract. Exhibit A lists the locations served under the Contract and the amount of firm and interruptible gas to be delivered to each location. The purpose of Revision Six is to, first as provided for in section 7 of the Contract, decrease the amount of Firm Agreement Demand and projected interruptible volumes at one location served under the Contract. Secondly, as provided for in section 4.b. of the Contract, is to delete two locations from the locations served under the Contract.

The first of the two changes included in Revision Six is effective January 1, 2009, this allows for the sixty-day notice to PSE by Boeing which is required by section 7 of the Contract. The second change is effective April 1, 2009, which allows for the 180-day notice to PSE by Boeing as is required by section 4.b. of the Contract.

The attached Revision Six contains customer specific information and, therefore, PSE requests that it be treated as “Confidential” and identifies the Boeing Company as the party that may be affected by disclosure of the information contained in Revision Six. In accordance with WAC 480-07-160, Revision Six has been marked as “Confidential per WAC 480-07-160”.
