## **Establishing Water Service and Fees**

Water service shall be rendered only after submitting a completed and signed application by the prospective customer and acceptance of the application by the water company. Please allow one business day for processing.

- One-time charge of \$55.00 (New Account Set-Up Fee) can be included with the application.
- Invoices for water utility services (Base Rate, Consumption, Flat Rate Billing, Ready to Service and any Additional Service Fees) are sent out monthly, with payment due upon receipt and past due fifteen (15) days from the date of invoice.
- A Payment Reminder Notice is mailed to customer with an unpaid balance thirty (30) days form the date of the invoice.
- If a Disconnection Notice is received, you must notify Tatoosh Water Company at 360-466-4443 that you are making a payment
  or run the risk of disconnection of service.
- When a Utility employee is dispatched (single visit) to disconnect service and service is not disconnected, that employee must accept payment of a delinquent account and the disconnect visit charge of \$150.00 will be charged. Disconnection visits will only be made following the required notice to the customer.
- When a Utility employee is dispatched (single visit) to reconnect service to the Utility distribution system a reconnection fee
  will be charged of \$150.00 8am-4pm Monday through Friday, or \$300.00 all other hours and Holidays. The Utility will restore
  service when the cause of discontinuance has been removed and payments of all proper charges due from customer have been
  made.
- If an account has been established under fraudulent means, a service may be terminated without further notice.
- A service charge of \$25.00 shall be applied to each account for each payment returned unpaid for any reason by the financial
  institution upon which payment is drawn.
- Ready to Serve Fees (per month): 3/4-inch meter=\$40.00, 1-inch meter=\$66.80, 1.5-inch meter=\$133.20, 2-inch meter=\$213.20, 3-inch meter=\$400.00, 4-inch meter=\$668.00, and 6-inch meter=\$1,333.20.
