**NOTICE GRANTING CONTINUANCE OF HEARING
AND CHANGE IN HEARING LOCATION
(Set for Friday, March 11, 2005)**

Re: In re Application of Pennco Transportation, Inc.
Docket No. TC-041340
In re Application of Heckman Motors
Docket No. TC-041593

TO ALL PARTIES:

These consolidated applications are currently set for evidentiary hearing on February 17, 2005. Since the time of the prehearing conference at which the evidentiary hearing was scheduled, the parties have engaged in settlement negotiations. As a result of these negotiations, the number of protestants to each application has been reduced.

Pennco Transportation. This application was initially protested by Bremerton-Kitsap Airporter, Inc., GrayLine of Seattle and Heckman Motors. As a result of settlement negotiations, the interests of Bremerton-Kitsap and GrayLine have been satisfied, assuming the Commission adopts the following revised authority:

PASSENGER SERVICE: Door to door, by reservation only:

BETWEEN: ~~Clallum and Jefferson Counties and Seattle and Tacoma hotels and cruise terminals.~~ Clallum and Jefferson Counties on one hand, and Seattle hotels and Tacoma hotels and Seattle cruise terminals on the other hand, with no service between Seattle hotels and Tacoma hotels and Seattle cruise terminals, and with closed door service between the indicated points.

BETWEEN: Clallam and Jefferson Counties and Kingston and Bainbridge Ferry Terminals.

~~BETWEEN: Kitsap County and Seattle and Tacoma hospitals, Amtrak stations, Greyhound stations, cruise terminals, hotels and the Seattle Tacoma International Airport with closed door service between Kitsap County and the indicated points in King and Pierce County.~~

BETWEEN: Kitsap County and Kingston and Bainbridge Ferry Terminals.

Removal of restriction against providing service:

To passengers from any point served by Heckman Motors, Inc. d/b/a Olympic Bus Lines, under Certificate No. C-992 without advance reservations made at least one hour in advance of the pick-up times at each such point indicated by Heckman Motors, Inc., d/b/a/ Olympic Bus Lines, schedule as published from time-to-time in accordance with WAC 480-30-060.

BETWEEN: Clallam and Jefferson Counties and Kitsap County Ferry Terminals.

Heckman Motors. This application was initially protested by Shuttle Express, Inc., Bremerton-Kitsap Airporter, Inc. and Pennco. As a result of settlement negotiations, Shuttle Express and Bremerton-Kitsap's interests have been satisfied, provided the Commission adopts the following revised authority:

PASSENGER SERVICE described as follows:

BETWEEN: Port Angeles, Sequim, Discovery Bay, Kingston, Edmonds, Silverdale, and Seattle.

No service shall be rendered between Seattle and Seattle-Tacoma International Airport, Silverdale and Seattle, Edmonds and Seattle, Edmonds and Seattle-Tacoma International Airport, and Silverdale and Seattle-Tacoma International Airport.

Continuance of proceeding. In light of the settlement, and a request from the two remaining parties, it is reasonable to continue the evidentiary hearing, now scheduled for February 17, 2005, in order to give the parties time to prepare for hearing. The parties have requested that the hearing be held on two days, one to take place in Port Angeles, Washington, the other to take place in Kingston, Washington. Owing to the logistical problems of scheduling a hearing such as this for two locations, the Commission will not honor the request for the Kingston hearing location.

NOTICE IS GIVEN That the Commission will continue the hearing currently scheduled for Thursday, February 17, 2005 to Friday, March 11, 2005. The hearing will take place in Port Angeles, Washington, commencing at 9:30 a.m. Notice of the exact location of the hearing in Port Angeles will be served separately. The parties must serve copies of their witness lists and exhibit lists on the Commission and each other on or before Monday, March 7, 2005.

All other provisions of the Prehearing Conference Order served on Monday, January 10, 2005, remain in full force and effect.
