
Description of amendment:

The Agreement is amended by adding terms and conditions for Unbundled Network Elements (UNEs) and Resale as set forth in Attachment 1 and Exhibit a to the Amendment.

The amendment amends the interconnection agreement first approved by the Commission on March 15, 2006 in WUTC Docket No. UT-063008.

Company A represents that the amendment does not discriminate against non-party carriers, that it is consistent with state and federal law, and that it is in the public interest. By virtue of Company B's signature on the amendment, Company A believes that Company B agrees with these representations.
