COMMNET WIRELESS LLC'S NOTICE OF CONDITIONAL RELINQUISHMENT OF ELIGIBLE TELECOMMUNICATIONS CARRIER DESIGNATION

Pursuant to 47 U.S.C. § 214(e)(4) and 47 C.F.R. § 54.205(a), Commnet Wireless, LLC ("Commnet"), submits this Notice of conditional relinquishment of its designation as an eligible telecommunications carrier ("ETC") to the Washington Utilities and Transportation Commission ("Commission"). As explained below, Commnet seeks relinquishment of its ETC status for only those census blocks in San Juan County, which are identified in Exhibit 1, conditioned on the following:

- (1) the Federal Communication Commission's ("FCC") approval of the joint Application of Communet and Island Network, LLC dba Rock Island Communications ("Rock Island") for Consent to Assignment of Domestic Section 214 Authorization ("Joint Application") and Rock Island satisfying the conditions imposed by the FCC for completion of the transfer of funding; and
- (2) the Commission's approval of Rock Island's Application for Designation as an Eligible Telecommunications Carrier.

In support of this Notice, Commnet states

1. Commnet is a Delaware limited liability company that provides voice and

broadband services in rural and tribal communities in the southwestern United States. Commnet is designated as an ETC in areas where it was awarded Rural Digital Opportunity Funds ("RDOF") in the State of Washington, including but not limited to, the census blocks in San Juan County identified in **Exhibit 1**.

- 2. Island Network, LLC dba Rock Island Communications ("Rock Island") is a Washington limited liability company based in Eastsound, Washington.
- 3. Following the FCC's announcement that Commnet was a winning bidder in the FCC's Rural Digital Opportunity Fund ("RDOF"), Commnet sought ETC designation before the Commission.
- 4. On May 20, 2021, the Commission issued an Order granting Commnet Petition for Designation as an Eligible Telecommunications Carrier for Purposes of Receiving Support from the Rural Digital Opportunity Fund, which included the census blocks identified in Exhibit 1.
- 5. On January 10, 2024, Commnet and Rock Island entered into an Assignment and Assumption Agreement, under which Commnet agreed to assign its RDOF obligations listed in Exhibit 1 to Rock Island, and Rock Island agreed to accept those funds and assume those obligations, subject to any required regulatory approvals. Commnet and Rock Island have agreed to work together to effectuate the assignment of Commnet's RDOF program obligations to Rock Island with respect to these census blocks listed in Exhibit 1.
- 6. Commnet and Rock Island submitted a Joint Application dated February 14, 2024 to the FCC, seeking FCC consent for the assignment of Commnet's domestic Section 214 authorization to Rock Island, which consists of Commnet's RODF support obligations for its designated census blocks in San Juan County, which are listed in Exhibit 1. A copy of the Joint

Application is attached at Exhibit 2.

- 7. On March 18, 2024, Rock Island filed its Application with the Commission seeking approval of its ETC designation in the census blocks in San Juan County, which are listed in Exhibit 1, where Commnet is currently authorized to receive RDOF support.
- 8. Following all regulatory approvals, and upon assignment, Rock Island will begin to receive RDOF funds for the transferred areas and assume Commnet's obligations to provide services pursuant to FCC rules.
- 9. Federal law authorizes relinquishment by one ETC where another ETC serves the area. 47 U.S.C. § 214(e)(4) states, in pertinent part:
 - A State commission . . . shall permit an eligible telecommunications carrier to relinquish its designation as such a carrier in any area served by more than one eligible telecommunications carrier. An eligible telecommunications carrier that seeks to relinquish its eligible telecommunications carrier designation shall give advance notice the State commission . . . of such relinquishment. Prior to permitting a telecommunications carrier designated as an eligible telecommunications carrier to cease providing universal service in an area served by more than one eligible telecommunications carrier, the State commission . . . shall require the remaining eligible telecommunications carrier or carriers to ensure that all customers served by the relinquishing carrier will continue to be served, and shall require sufficient notice to permit the purchase or construction of adequate facilities by any remaining eligible telecommunications carrier. The State commission . . . shall establish a time, not to exceed one year after the State commission . . . approves such relinquishment under this paragraph, within which such purchase or construction shall be completed.
- 10. The FCC rules support approval of Commnet's requested ETC relinquishment.

 47 C.F.R. § 54.205 provides that a "state commission shall permit an eligible telecommunications carrier to relinquish its designation as such a carrier in any area served by more than one eligible telecommunications carrier." 47 C.F.R. § 54.205(a).
- 11. Once Rock Island's Application pending before the Commission, and the Joint Application pending before the FCC, are both approved, the necessary criteria for relinquishment will be satisfied.

THEREFORE, based on the foregoing, Commnet respectfully requests the Commission issue an order granting its request for relinquishment, conditioned upon the FCC's approval of the Joint Application and the Commission's approval of Rock Island's Application seeking ETC designation in the census blocks listed in Exhibit 1.
