# NOTICE OF OPPORTUNITY TO FILE WRITTEN COMMENTS ON PROPOSED RULES (By July 18, 2022)

## NOTICE OF PROPOSED RULE ADOPTION HEARING (Set for August 1, 2022, at 1:30 p.m.)

Re: Rulemaking pertaining to the establishment of minimum crew sizes on certain trains, Docket TR-200536

#### TO ALL INTERESTED PERSONS:

The Washington Utilities and Transportation Commission (Commission) provides this notice to inform you of the progress made in this rulemaking docket concerning the possible adoption of proposed revisions to WAC 480-62, Railroad Companies – Operations. The changes implement House Bill 1841 (HB 1841), Laws of 2020, Chapter 170, which pertains to the establishment of minimum crew sizes on certain trains. HB 1841 adds new sections to, and repeals specific sections in, chapter 81.40 RCW, necessitating a rulemaking to define Class I railroads, develop a mechanism for reviewing automatic waivers, and establish a process for Commission-ordered crew size increases.

On July 20, 2020, the Commission filed with the Code Reviser a Preproposal Statement of Inquiry (CR-101). The Commission is directed by the Legislature in chapter 81.40 RCW to:

- Apply specific definitions to this rule.
- Require common carriers of freight or passengers in the state, with specific exceptions, to operate and manage all train crews and switching assignments with no less than two crewmembers.

• Grant automatic waivers to the train crew size requirement in RCW 81.40.015 to certain railroad carriers.

- Order railroad carriers to increase the number of railroad employees, require additional
  crewmembers, or direct the placement of additional crewmembers, if the Commission
  determines the increase is necessary to protect the safety, health, and welfare of the
  public, passengers or railroad employees, to prevent harm to the environment, or to
  address site specific safety or security hazards.
- Assess fines for violations of the rule.

The effect of the proposed rule (WAC 480-62-255) and the amendment to WAC 480-62-125 is the implementation of the new legislation.

The Commission circulated draft rules, reviewed the comments it received from stakeholders, and prepared proposed rules for adoption. The Commission also issued two Small Business Economic Impact Statement Questionnaires to obtain information on any economic impact of these rules on the companies. The Commission received no responses to either questionnaire. The draft rules, comments, and questionnaire are available on the Commission's website at <a href="http://www.utc.wa.gov/200536">http://www.utc.wa.gov/200536</a>.

On March 18, 2022, the Commission filed a Notice of Proposed Rulemaking (CR-102) with the Office of the Code Reviser. Pursuant to the CR-102, the Commission held an adoption hearing on May 19, 2022.

In June 2022, the Commission became aware that one of its primary stakeholders had not been served with the CR-102 and had been aware of neither the date of the adoption hearing nor the opportunity to comment on the proposed rules. To rectify the omission and provide ample opportunity for all interested persons and stakeholders to comment on the proposed rules, the Commission filed a supplemental Notice of Proposed Rulemaking (Supplemental CR-102) with the Code Reviser on June 22, 2022. The proposed rules would implement legislation passed in 2020, HB 1841, Laws of 2020, chapter 170. The proposed rules are available for inspection on the Commission's website at <a href="https://www.utc.wa.gov/casedocket/2020/200536/docsets">https://www.utc.wa.gov/casedocket/2020/200536/docsets</a>. The Supplemental CR-102 filing restarts the final phase of the rulemaking process, which includes a written comment period, a public adoption hearing, and the Commission's decision.

#### WRITTEN COMMENTS

The Commission gives notice of the opportunity to submit written comments on the proposed rules. Written comments must be filed with the Commission by **5 p.m. on July 18, 2022**. Pursuant to WAC 480-07-250, written comments on draft rules must be submitted to the Commission in electronic form.
