<u>ORDER</u>

I On January 11, 2008, the Public Counsel Section of the Washington State Attorney General's Office (Public Counsel) filed a motion requesting that the Washington Utilities and Transportation Commission (Commission) hold four joint public hearings in the above-docketed matters and the matter styled Joint Application of Puget Holdings LLC and Puget Sound Energy, Inc. (PSE), in Docket U-072375, which concerns the proposed sale of PSE to a consortium of investors led by the Macquarie Group of Companies. Public Counsel proposed alternative locations, preferred dates and a preferred starting time of 6:30 p.m. for each hearing. The Commission consulted informally with the parties via e-mail to narrow the range of dates and locations.¹

¹ Public Counsel filed on January 28, 2008, a paper styled "Joint Motion for Interlocutory Review or Reconsideration." The Commission's procedural rules provide for review of prehearing and interlocutory <u>orders</u> at WAC 48-07-430 and -810, respectively. Public Counsel's "motion," joined by the Northwest Energy Coalition and The Energy Project, was premature and not within the scope of what is allowed under the procedural rules. It was filed in reaction to an informal e-mail to the parties announcing a preliminary determination regarding the number of public comment hearings to be held and requesting additional

- 2 The Commission determines that three public comment hearings in diverse locations in PSE's service territory will provide sufficient opportunities for members of the public to comment orally on the record of these proceedings. These hearings are in addition to the continuing opportunity for members of the public to submit written comments to the Commission in the general rate proceeding (Dockets UE-072300 and UG-072301) and the transfer of property proceeding (Docket U-072375), either directly or via Public Counsel, until the record is closed in each proceeding.
- 3 The Commission grants Public Counsel's motion, in part, and gives notice below of the date, time, and community in which each public comment hearing will be held. The Commission will arrange for facilities in each community and will announce their locations by subsequent notice.

4 THE COMMISSION GIVES NOTICE that it will conduct joint hearings to receive comments from members of the public concerning PSE's general rate proceeding in Dockets UE-072300 and UG-072301 (consolidated), and PSE's application in Docket U-072375 for approval of the proposed acquisition of the company by a consortium of investors, according to the following schedule:

The Commission will give further notice concerning the precise location for the conduct of these public comment hearings once facilities are arranged.
