BENCH REQUEST NO. 1

The Public Counsel Unit of the Washington Attorney General's Office (Public Counsel) hereby offers this Public Comment Exhibit Bench Request No. 1 (BR-1) for admission into the record for this proceeding in Docket UE-210829 concerning the Clean Energy Implementation Plan (CEIP) proposed by PacifiCorp, d/b/a Pacific Power & Light Company (PacifiCorp or Company). On August 29, 2023, the Washington Utilities and Transportation Commission (UTC or Commission) issued a Notice of Virtual Public Comment Hearing (Notice), which the Commission revised on September 1, 2023, to clarify the Public Comment Hearing time and date of 6 p.m. on September 28, 2023. The Commission and Public Counsel both received and compiled remarks from customers in response to the Notice. Customers either provided comments to Public Counsel via phone calls and emails or provided comments to the Commission through the UTC's online comment web portal.

Public Comment Exhibit No. BR-1. The Commission Consumer Protection and Communications Staff documented these customer comments in a database matrix. The output from this database is included in .pdf format as Attachment 1 to this exhibit,³ and this file provides all comments submitted to the Commission. Public Counsel also received four phone calls and two written comments. These comments are included in Attachment 2.⁴ Ms. Rathburn submitted comments to Public Counsel via written letter and also left a voicemail. Both of Ms. Rathburn's comments are left in Attachment 2 for the totality of evidence.⁵

The database matrix in Attachment 1 contains all comments submitted to the Commission through their online web portal in response to the Notice up to October 5, 2023. The date of October 5, 2023, was the final date to submit comments in this Docket set by the Commission at the September 28, 2023, Public Comment Hearing. The Commission provided the output shown in Attachment 1 to Public Counsel on October 12, 2023.

Although the CEIP does not propose a rate increase, many of the comments opposing the CEIP discuss rates and the prospect of rates increasing as a result of the CEIP. The commenters discussing rates do not identify any pending requests by PacifiCorp for rate adjustment, but discuss the possibility of future rate increases that may or may not arise from or reference activities discussed in the CEIP.
