> created a MAJOR barrier to net metering by requiring - rather
> arbitrarily in its interconnection agreement - that PSE be listed as an additional
insured on the homeowner's insurance policy. This is already preventing customers
from signing up w/ PSE. I believe that I suggested that in the net metering rule that
the UTC defer to the interconnection standards of the IEEE (International elctronic
and Electrical Engineers ).
> The intention is to AVOID arbitrary interconnection standards such as
> those PSE has proposed.
> If you'd make a pitch for this at the meeting, I'd appreciate it. If you want to
indicate that I brought it to your attention, feel free.
