On July 13, 2017, the Commission issued Order 06, Order Approving Settlement Agreement, in Docket UE-161123 ("Order 06") approving the settlement agreement reached by Microsoft, PSE, the Commission staff, Public Counsel, and the other interveners (the "Settlement Agreement"). The Settlement Agreement which was incorporated in its entirety by the Commission into Order 6 allows Microsoft to relinquish its PSE core customer status and take service from PSE under a special contract. Exhibit A to the Settlement Agreement is the Special Contract that PSE and Microsoft agree to for the non-core service (the "Special Contract"), which establishes the terms and charges of that non-core service. The approval of the Special Contract eliminated the need for the tariff filing made by PSE on October 7, 2016. Therefore, PSE respectfully requests that it be allowed to withdraw the October 7, 2016 tariff filing described above.

In accordance with WAC 480-80-131(6), the request to withdraw the tariff filing described herein is being made by Ken Johnson who has authority to withdraw the filing on behalf of PSE.
