T. INTRODUCTION AND DISCUSSION

On March 20, 2006, Petitioners filed a motion to add fourteen residents as petitioners to this proceeding. In support of their motion, Petitioners state that they "have been influenced by Respondent's argument that the cost of line extensions on a per customer basis is 'well above the norm." In light of Commission Staff's limited role in this case, Staff takes no position on Petitioners' motion. However, as a general proposition, Staff is opposed to parties to Commission proceedings substantially revising their testimony within two weeks of the scheduled hearing. It may be necessary to, once again, devise a new procedural schedule.
