COLUMBIA RURAL ELECTRIC ASSOCIATION'S MOTION FOR EXTENSION OF TIME TO RESPOND TO BENCH REQUEST

Pursuant to WAC § 480-07-375, the Columbia Rural Electric Association ("Columbia REA") respectfully moves for an extension of the deadline for responding to the Washington Utilities and Transportation Commission's ("Commission") Bench Request No. 1 to Columbia REA, issued on June 16, 2017 in the above-captioned proceeding. The deadline for responding is currently June 30, 2017. Columbia REA requests a deadline for responding of July 14, 2017.

The Commission's bench request seeks "a list of each instance in which Columbia REA has assumed or reimbursed the costs of permanent disconnection ... for a departing Pacific Power customer." It further requests, for each instance, "the customer's class ... the date of payment(s), and the total amount paid."

The scope of this request, coupled with the fact that certain key personnel necessary for compiling a response have scheduling conflicts over the next two weeks, will likely prevent Columbia REA from providing a full response by the established deadline.
