

TELECOMMUNICATIONS SERVICES AGREEMENT  
BETWEEN  
VERIZON SERVICES ORGANIZATION INC.  
AND  
MCI COMMUNICATIONS SERVICES, INC.

This Amendment 21 to the Telecommunications Services Agreement (Contract No. TSA010302-1) (Agreement) by and between MCI Communications Services, Inc. d/b/a Verizon Business Services, a Delaware corporation, with offices at 6929 North Lakewood Avenue, Tulsa, Oklahoma 74117 ("Provider") and Verizon Services Organization Inc., a Delaware corporation, with offices at 6665 N. McArthur Boulevard, Irving, Texas 75039 ("Customer") shall be effective as of the date set forth below.

1. EFFECTIVE DATE.

This Amendment 21 shall be effective upon the execution by both parties (the "Amendment 21 Effective Date").

2. ADDITIONAL CUSTOMER AFFILIATE.

The parties acknowledge that Exhibit A (Affiliated Entities) includes "Verizon International Teleservices, C. por A" (which was formerly known as "Informática y Telecomunicaciones, C. por A. (Dominican Republic)").

3. AGREEMENT MODIFICATION.

3.1 ADD a new Section 42, LOCAL SERVICE, to Exhibit C as set forth in **Attachment 1**.

3.2 Exhibit C, ADD a new Attachment C-20, LOCAL SERVICE CHARGES, as set forth in **Attachment 2**.

4. OTHER TERMS AND CONDITIONS.

Except as specifically amended herein, the terms and conditions of the Agreement, including any Amendments thereto, shall remain in full force and effect during the term of the Agreement.

**ATTACHMENT 1**

**(ADD THE FOLLOWING AS A NEW SECTION 42 TO EXHIBIT C)**

41. WAVELENGTH SERVICE

41.1 Scope. Upon Customer's request and where available, Provider will provide and Customer agrees to pay for 2.5 or 10 Gbps Option 1 Type I interLATA or intraLATA optical circuits delivered as a protected or unprotected signal using Dense Wave Division Multiplexing (DWDM) and Optical Add/Drop Multiplexing (OADM) technology ("WAVELENGTH Service"). WAVELENGTH Service is delivered using one of several option interfaces, including without limitation, GigE, OC-48 SONET, OC-192 SONET, ESCON, FICON and Fiber Channel.

41.2 Charges for WAVELENGTH Service. Customer's charges for WAVELENGTH Service will be determined on an individual case basis and shall be established upon Provider's acceptance of a Service Order therefor.

42. LOCAL SERVICE

42.1 Scope Provider will provide Customer "LOCAL SERVICE" subject to the terms, conditions, charges and discounts set forth herein. LOCAL SERVICE includes the following:

42.1.1 Facilities-based local exchange digital T-1 (basic, DID and 2-way configurations);

42.1.2 ISDN-PRI;

42.1.3 Integrated T-1;

42.1.4 Virtual foreign exchange (VFX) service (inbound only);

42.1.5 Remote Call Forwarding which allows dialed calls to be forwarded to a specific local, toll or toll free number; usage charges will apply if the target number is a toll or toll free number; monthly charges also apply per path (i.e., a simultaneous call);

42.1.6.1 Overflow Routing which allows calls to a telephone number to be sent to another pre-selected number when the dialed number is busy (toll charges will apply if the overflow number is outside the local calling area);

42.1.7 Disaster Recovery which is a collection of actions, procedures and information developed and held in readiness for use in the event of a lengthy disruption of Customer's Local Service; Disaster Recovery must be activated at Customer's request and may employ Remote Call Forwarding and alternate routing; Disaster Recovery is billed per service address and number of telephone numbers included in the plan;

42.1.8 Equal Access;

42.1.9 Universal Calling;

42.1.10 Service Access Codes (500, 700 and 8XX services);

42.1.11 Directory Assistance Information (411);

42.1.12 Directory Listings (one standard listing in the LEC white pages and yellow pages will be provided at no charge; additional listings and alternate call listings are available for an additional charge);

42.1.13 Hunting;

42.1.14 Operator Services;

42.1.15 Telecommunications Relay Services; and,

42.1.16 911, E911 and private switch/automatic location identification (PS/ALI) information.

42.1.17 LOCAL SERVICE does not include telephone number assignment (TNA) to the End User, 900/976 access, business lines, analog trunks or customer premises equipment (CPE). The minimum LOCAL SERVICE provided hereunder is at the T-1 level with a maximum of six (6) trunk groups per T-1.

42.2 Minimum Circuit Term Commitment. All LOCAL SERVICE circuits ordered hereunder are subject to a minimum Service Commitment Period of at least twelve (12) months ("Minimum Circuit Term Commitment"). Customer may terminate a LOCAL SERVICE circuit if Customer provides written notification thereof to Provider at least thirty (30) days in advance of the effective date of termination. Notwithstanding anything to the contrary contained in the Agreement, if Customer cancels or terminates a LOCAL SERVICE circuit prior to the expiration of the applicable Service Commitment Period for such Circuit as selected by Customer on the Service Request, Customer agrees to pay one hundred percent (100%) of the applicable Local Service monthly recurring charges that would have otherwise become due through the remainder of the Service Commitment Period. Customer will pay any early termination charges owed hereunder within thirty (30) days following such termination. Notwithstanding the termination of a LOCAL SERVICE circuit, all other LOCAL SERVICE circuits will remain in full force and effect.

42.3 Customer Responsibilities.

42.3.1 Customer is responsible for coordinating all necessary interaction with Customer's End Users and providing to Provider all necessary End User information in connection with the provision of LOCAL SERVICE to End Users and any LOCAL SERVICE capabilities required by applicable law, including Equal Access, Universal Calling, Service Access Codes (500, 700, and 8XX services), Directory Assistance Information (411), Directory Listings, Hunting, Operator Services, Telecommunications Relay Services, 911, E911 and PS/ALI. Customer must offer and coordinate such activities in a manner consistent with Provider's Tariffs (or Guide) and standard service intervals. Customer shall cooperate with Provider to ensure that End Users' telephone numbers are properly assigned in accordance with industry engineering standards and regulatory requirements. Customer represents and warrants that it is currently in compliance with and shall continue to comply with all applicable laws, including any competitive local exchange carrier (CLEC) certification requirements in any jurisdiction required by applicable law.

42.3.2 If Customer resells LOCAL SERVICE through a PBX or any service that uses blocks of DIDs (e.g., shared tenant services), and desires to provide End User telephone number and specific ALI display on a 911 call in order to comply with applicable law or for any other reason, Customer must acquire and implement a PS/ALI solution. Absent the implementation of PS/ALI by Customer, Customer's name, Customer's main Billing Telephone Number (BTN) and Customer's address will display on a 911 call (i.e., no End User details will be in the 911 database). Customer must complete a Provider PS/ALI Letter of Authorization (LOA) for each PBX location prior to the PBX passing station-level ANI on a 911 call. Customer is responsible for complying with all applicable 911 laws. For non-PBX LOCAL SERVICE, at the time the Service Request is placed Customer will provide to Provider correct and complete End User data to fulfill both Provider order processing needs as well as 911 requirements. Provider will provide any errors or trouble reports resulting from order processing to Customer for resolution within 24 hours.

42.3.3 Customer and Customer's End Users may not use LOCAL SERVICE, directly or indirectly, to provide a service that constitutes exchange access and/or is subject to the application of access charges under applicable law. Provider reserves the right to: (i) request that Customer and/or Customer's End Users provide written certification that it is using LOCAL SERVICE in compliance with this requirement; and/or (ii) conduct a site survey of Customer and/or Customer's End Users' premises or an audit of Customer and/or Customer's End Users' books and records upon reasonable notice or take other reasonable measures to satisfy itself that Customer and/or Customer's End Users are using LOCAL SERVICE in compliance with this requirement. Notwithstanding anything to the contrary contained in the Agreement, in the event Customer and/or Customer's End Users are found to be using LOCAL SERVICE in violation of this requirement, Provider may immediately discontinue the provision of LOCAL SERVICE without notice. Customer shall indemnify Provider for any liability, losses, penalties or payments (including without limitation access charges and reasonable attorneys' fees) incurred due to Customer's or its End User's misuse of LOCAL SERVICE.

42.3.4 In order to assure that emergency calls are routed to the Public Safety Answering Point serving the geographical area associated with Customer's End User's telephone number, Customer and Customer's End Users may not use foreign exchange service to place outbound calls including, but not limited to, calls to 911 emergency numbers. [Note: Provider strongly recommends that each End User maintain at least one telephone exchange service access line bearing an NPA-NXX designation associated with the End User's actual geographic location for emergency use.]

42.3.5 With respect to shared tenant applications, Customer must provide an adequate usage forecast to request blocks of DID telephone numbers. Customer is required to maintain detailed records of its number assignments to End Users, and to provide reports to Provider specifying the aggregate of all assigned numbers from the range of allocated intermediate numbers. Customer will provide such reports, as well as any other information reasonably required by Provider at periodic intervals specified by Provider to enable Provider Verizon to comply with all applicable federal and state laws. If Customer has its own Operating Company Number (OCN), Customer is responsible for reporting utilization and forecast data directly to the North American



Numbering Plan Administrator (NANPA) instead of to Provider. LOCAL SERVICE is provided subject to Provider's policies and procedures, including without limitation policies and procedures regarding number requests and number utilization, as may be modified from time to time.

**42.3.6** If Provider suspends or disconnects any LOCAL SERVICE to Customer for any reason, Customer must provide necessary notice to its affected End Users. Notwithstanding the foregoing, if Provider terminates the Agreement for cause, or Provider suspends, refuses or delays LOCAL SERVICE due to Customer's breach of any provision contained herein, Provider may, in its sole discretion, offer LOCAL SERVICE to Customer's End Users on a temporary basis from the date of such termination, suspension, refusal or delay for a period not to exceed thirty (30) days. Provider's offer of temporary LOCAL SERVICE is as a courtesy and shall be offered at Provider's standard terms and conditions, including standard tariffed rates. In such case Customer agrees, upon Provider's request, to provide Provider a list of the names, addresses and telephone numbers of Customer's End Users so that Provider may contact the End Users to provide temporary LOCAL SERVICE in accordance herewith.
