Pursuant to 47 C.F.R. § 52.23 Sprint Communications Company L.P. ("Sprint") submits this letter as its Local Number Portability Bona Fide Request (LNP "BFR") to Whidbey Telephone Co. The purpose of this BFR is to initiate the six-month regulatory timeline established under section 52.23(c) to ensure LNP functionality is available to Sprint in Whidbey Telephone's service area.

Section 52.23(c) states that "all LECs must make a long-term database method for number portability available within six months after a specific request by another telecommunications carrier in areas in which that telecommunications carrier is operating or plans to operate.

Sprint plans to operate in the service area of and has sent or will be sending a request to negotiate an interconnection Agreement with Whidbey Telephone Co. Please note, however, that there is no requirement that the interconnection agreement be completed prior to initiating the six-month timeline in 47 C.F.R. § 52.23(c). Sprint CLEC will utilize the Service Provider iD (SPID) of 8712 to provide telecommunications services in Washington and to place local number porting requests with your company. Specifically, Sprint requests local number portability capabilities in the rate centers outlined in the attached document.

Please provide Sprint with the status of these rate centers regarding their Local Number Portability capabilities (i.e. software, hardware, remotes) within 10 days of your receipt of this request.

If Whidbey Telephone Co. does not believe it is required to comply with 47 C.F.R § 52:23, please explain the company's position and include all supporting documentation within 10 days of your receipt of this request.
