The Commission has jurisdiction over the provision of solid waste collection services in all of Washington state. Accordingly, you are required to appear before the Commission, and no other judicial body at this time.

If you wish to seek damages against the Commission, you will need to do that separately from this proceeding. I cannot provide you with any further legal advice on that matter.

I will not entertain your accusations regarding commission staff prank calling you.

If you fail to appear at the virtual hearing on 11/17, you will be held in default. We can discuss at that time whether there is truly a need to reschedule, but because you have been uncooperative and difficult to serve, I will not grant your motion to continue the hearing. I will talk to you next week, 11/17, at 10 a.m.

As a courtesy, I am forwarding your request to the Commission's records center. The records center will treat your email below as a request for public records and respond to you accordingly. To clarify, the last order entered in this case vacated the default order against you, but also reopened the proceeding for further process. I've attached that order to this email for your reference. Also, to clarify, your case is assigned Docket TG-190793.

As it stands, Staff is pursuing its original complaint to classify you as a solid waste collection company and you are required to prove that you are not, or are no longer, providing such service to avoid penalties. Accordingly, your appearance is required at the brief adjudicative proceeding before the Commission that is set for Tuesday, November 17, 2020, at 10 a.m. I am the judge presiding over that proceeding, so I will speak with you about this matter at that time.
