RE: Puget Sound Energy's Planned Sale of a Material, Non-controlling 31.57 percent interest in Puget Holdings, LLC, Docket U-210542

TO ALL INTERESTED PERSONS:

On July 9, 2021, Puget Sound Energy (PSE) filed with the Washington Utilities and Transportation Commission (Commission) a Joint Application with the Ontario Teachers' Pension Plan Board (Ontario Teachers) and Macquarie Washington Clean Energy Investment, L.P., (Macquarie) (collectively, Joint Applicants) for an order authorizing proposed sales of indirect interests in PSE (Joint Application).

The Joint Applicants request the Commission authorize the transfer of the upstream, non-controlling 31.57 percent indirect ownership interest in PSE currently held by Canada Pension Plan Investment Board to the Ontario Teachers and Macquarie. If the Joint Application is approved, Ontario Teachers and Macquarie will each acquire a 15.785 percent equity interest in PSE's parent company, Puget Holdings, LLC. **OPEN MEETING**

On October 6, 2021, the Commission issued a notice this Docket informing interested persons and stakeholders that this matter would be heard at its regularly scheduled open meeting on December 9, 2021. The Commission subsequently issued an amended notice rescheduling this matter for the Commission's regularly scheduled open meeting on December 23, 2021. On December 2, 2021, Commission Staff determined that stakeholders and other interested persons require additional time to review and conduct informal discovery regarding PSE's recent changes to the Joint Application and to negotiate changes to PSE's proposed commitments. The Commission accordingly extends the deadline for filing comments until January 7, 2022, and reschedules this matter for its second open meeting in January.

The Commission will hear this matter and allow time for interested persons and stakeholders to provide feedback at its regularly scheduled open meeting on **Thursday, January 27, 2022, beginning at 9:30 a.m.** The Commission's open meetings are conducted virtually via Zoom.
