Michael,

Good Day. I am reaching out to you one more time, for reconsideration to withdraw your application to extend your authority.

I am concerned about what we discovered about the operations of your Company, Seattle Express. There is ample evidence that Seattle Express has operated illegally since the 2021 cruise ship season or longer, selling and operating one way fares on the very route, between Pier 66/Pier 91 and SeaTac Airport, that you are applying for through your extension of authority application in WUTC TC-220090. Providing this scheduled passenger transportation service infringes on our Company's certificated authority. The tickets have been sold and purchased for this service, on your website, before and after you filed the application to extend authority until this past week, clear violations of RCW 81.68.020 and RCW 81.68.040. Furthermore, just because you quickly removed the option after you realized the results of our own due diligence, does not remove or excuse the violations. RCW 81.68.030 would allow the WUTC to not only void or cancel your current application of extension of authority, but also revoke your current authority.

In 2017, your Company has filed two Formal Complaints against other Companies, specifically asserting violation of RCW 81.68.020 and RCW 81.68.040. The cases, both involving the BAP process, resulted in steep fines for the Respondent Companies that claimed ignorance, being "unaware (their)...conduct was unlawful", or "apologized for providing service...not authorized to provide." As you previously stated, Seattle Express has operated with Auto Transportation authority since 1996. Beeline Tours LTD / Seattle Express is experienced and knowledgeable of all the WUTC Auto Transportation Rules and Regulations, including WAC 480-30 and RCW 81.68.

I also believe that adversarial relationships are not helpful in business, especially when both of our businesses are and can become more complementary to one another and the traveling public. It is very important for Auto Transportation Companies to operate within the scope of their certificated authority. I sincerely hope you reconsider your position in this matter. Your fleet of larger vehicles with tours, charters, and scheduled services complementing a partnership with our business with a fleet majority of vans and some larger vehicles, operating door-to-door, scheduled services and charters. I am offering again the opportunity to work together, as we can both build a strong passenger transportation industry in the Seattle area.

While I wholeheartedly agree that working together would both benefit our companies, I don't agree that it should be predicated upon Beeline withdrawing its current application for extending our authority.

Seattle Express has operated in the cruise shuttle business since 1996, this application is a natural extension of our longtime existing business, and will allow us to provide additional services to our base of customers as well as open up new doors to developing and growing our business.

The problem for me with a working agreement or contract is it can't provide me with the same security as operating authority, we're looking at making substantial investments in this business line and I can't risk these investments being jeopardized by future contract negotiations with a friendly competitor.

It's my belief with an estimated 1.26 million revenue passengers for this upcoming 2022 cruise season there is more than enough business for both our companies.

I agree with you that the BAP is expensive and time-consuming, I would ask that you reconsider your protest as there is plenty of room for both companies to flourish. I believe Beeline has a very strong case and compelling argument for why consumers would benefit from our business model. If you were to withdraw your protest, it would solidify our ability to work together to deliver the best possible service for the traveling public. Having an adversarial type relationship will only hurt both our companies and is not in line with my approach to business.

I do appreciate you reaching out, hopefully, what I've said makes sense to you and we can focus on how to maximize our opportunities instead of wasting time and money with a court case.

FYI - We have no plans to provide scheduled service from Sea-Tac Airport to downtown Seattle hotels, the application was updated to reflect this reality.
