On August 31, 2017, Cascade Natural Gas Corporation (Cascade or Company) filed with the Washington Utilities and Transportation Commission (Commission) revisions to its currently effective Tariff WN U-3. The purpose of this filing is to increase rates and charges for natural gas service provided to customers in the state of Washington. Specifically, Cascade requests authority to increase charges and rates for natural gas service by approximately \$5.9 million, or 2.71 percent in base rates. The Commission suspended the as-filed tariff and set the matters for hearing.

On October 10, 2017, the Commission entered Order 03, Prehearing Conference Order; Notice of Hearing (Order 03). In Order 03, the Commission stated that the time and place for public comment hearings would be determined at a later date. The Commission now establishes the time and place for public comment hearings to provide members of the public with an opportunity to present oral comments to the Commission. The Commission will accept written comments until the record in this proceeding is closed.
