This is something we have offered in the past. For the meetings that were held for the CEIP Biennial Report, PacifiCorp took the approach of offering these virtual and recorded. The recording of the meetings are posted PacifiCorp's CEIP webpage, so anyone can go back and review the recording as well as printout the presentation and notes, both of which are offered in English and Spanish.

Examples: CBI condition 11, or interim target condition 2	Consistent with Interim Target Condition 1, the Company has provided revised interim targets in this CEIP Update, and the Company will continue working to implement the remaining conditions in future filings, consistent with the Settlement Agreement and Order 06.

Where available, details should include incentive levels, program details, timeline for program development/enrollment/deployment, expected contribution to CEIP Demand Response Specific Target by program by year, any budget updates, and any other program details relevant to specific programs. Staff is open to discussing whether some of these details could be included instead (or additionally) in its biennial conservation plan, rather than the CEIP update.	PacifiCorp has addressed this by providing an update on the Demand Response Actions starting on page 24 of the CEIP Biennial Report and in Appendix A.
