5 **Q. Please state your name and business address.**

6 A. My name is Joshua J. Jacobs. My business address is 355 110th Ave NE Bellevue,
7 WA 98004.

8 **Q. By whom are you employed and in what capacity?**

9 A. I am employed by Puget Sound Energy (“PSE”) as Vice President, Clean Energy
10 Strategy.

11 **Q. What are your duties as Vice President, Clean Energy Strategy?**

12 A. I lead PSE’s long-term resource planning efforts tied to our gas and electric
13 integrated resource plans, PSE’s planning process tied to our compliance with the
14 Clean Energy Transition Act, and the coordination and development of various
15 PSE clean energy strategies.

16 **Q. Briefly describe your education and relevant employment experience.**

17 A. I am a graduate of Northwest University in Kirkland, Washington, where I earned
18 a bachelor’s degree in business administration.

19 I joined PSE in 1998 and have served in various roles within the Company
20 including customer service, materials management, energy supply, and grid
21 operations. The majority of my career has been spent in energy supply managing

1 power and gas supply operations. In 2012, I took on the role of Director, Load
2 Serving Operations and was responsible for overseeing the management of PSE's
3 bulk electric system and also led regional policy initiatives related to the bulk
4 electric system on behalf of the Company. In 2016, I led the team for PSE's
5 CAISO EIM implementation directing both the technology and policy initiatives
6 for PSE's entrance into the market. Near the end of 2016, I assumed the role of
7 Director, Business Integration where I led the implementation of PSE's Get to
8 Zero initiative. I was promoted to my current role in March of 2021.
