Ms. Amanda Maxwell:

On November 23, 2022, the Washington Utilities and Transportation Commission (Commission) entered Order No. 01 (Order or Order 01) in Docket UE-220441, Order Approving 2021 Power Cost Adjustment Mechanism Deferral Balance. The Order approved PacifiCorp, d/b/a Pacific Power & Light Company's (PacifiCorp or Company) 2021 deferral balance of \$25,572,345 and their petition to extend the amortization period of the PCAM balance from 12 to 24 month. Additionally, the Order approved the filing which included the creation of a Production Tax Credit Tracker and a \$3.1 million surcharge to customers.

On December 8, 2022, in compliance with Order 01, PacifiCorp filed revised tariff sheets for electric Tariff WN U-76. The combined revisions to Tariff WN U-76 reflect an approximately \$15.9 million increase in electric base revenue for 2023, or approximately \$28.6 over the course of 24 months beginning January 1, 2023.

Commission staff has reviewed the Company's compliance filings, as revised on December 8, 2022. Staff believes that the revised tariff revisions contained therein comply with Commission Order 01, entered November 23, 2022. The tariff sheets indicated on the attachment to this letter will become effective January 1, 2023.
