5 **A.** I am a consultant in the field of public utility regulation and a Principal in the firm of
6 Brubaker & Associates, Inc., energy, economic and regulatory consultants.

7 **Q. PLEASE STATE YOUR EDUCATIONAL BACKGROUND AND**
8 **EXPERIENCE.**

9 **A.** I graduated from Southern Illinois University at Carbondale in 1984 with a Bachelor
10 of Science degree in Engineering. During college, I was employed by Central Illinois
11 Public Service Company in the Gas Department. Upon graduation, I accepted a
12 position as a Mechanical Engineer at the Illinois Department of Energy and Natural
13 Resources. In the summer of 1986, I accepted a position as Energy Planner with City
14 Water, Light and Power, a municipal electric and water utility in Springfield, Illinois.
15 My duties centered on integrated resource planning and the design and administration
16 of load management programs.

17 From July 1989 to June 1994, I was employed as a Senior Economic Analyst
18 in the Planning and Operations Department of the Staff of the Illinois Commerce
19 Commission. In this position, I reviewed utility filings and prepared various reports
20 and testimony for use by the Commission. From June 1994 to August 1997, I worked
21 directly with a Commissioner as an Executive Assistant. In this role, I provided
22 technical and policy analyses on a broad spectrum of issues related to the electric, gas,
23 telecommunications and water utility industries.

1 In May 1996, I graduated from the University of Illinois at Springfield with a
2 Master of Business Administration degree.

3 In August 1997, I joined Brubaker & Associates, Inc. as a Consultant. Since
4 that time, I have participated in the analysis of various utility rate and restructuring
5 matters in several states and the evaluation of power supply proposals for clients. I am
6 currently a Principal in the firm.
