TO ALL PARTIES:

The Commission entered its Order 08, Final Order Approving and Adopting Multi-Party Settlement Stipulation; and Requiring Compliance Filing in consolidated Dockets UE-080416 and UG-080417 on December 29, 2008. The order, among other things, rejected Avista Utilities' (Avista) original tariff filing, but authorized and required the Company to file tariff sheets consistent with terms of Order 08. The order also authorized the Commission's Executive Director and Secretary to approve the authorized filing, by letter, if it complied with the terms of the order.

On December 30, 2008, Avista filed revised tariff sheets. Based on Staff's review, Avista filed replacements for three of those sheets on December 31, 2008. A list of the tariff sheets is attached to this letter. The Commission has examined both filings and they appear to comply with the terms of the order.

Therefore, pursuant to terms of the Commission's Order 08 in this proceeding, the tariff sheets indicated on the attachment to this letter will become effective as filed with an effective date of January 1, 2009.
