TO ALL PARTIES:

The Commission entered its Order 08 Rejecting Tariff Sheets; and Authorizing and Requiring Compliance Filing in this docket on June 21, 2007. The order, among other things, rejected a tariff proposal by PacifiCorp, but authorized and required the Company to file tariff sheets consistent with terms of Order 08.
