Dear Sir or Madam:

As you are aware, on August 14, 2017, the Washington Utilities and Transportation Commission issued Order 02 imposing penalties in the amount of \$10,000, and suspending \$6,700 on condition of future compliance, i.e., ceasing and desisting all operations and payment of the \$3,300 unsuspended portion of the penalty. On February 28, 2018, the Commission issued Order 03 Imposing Suspended Penalty, in the amount of \$6,700, for continuing to operate without first obtaining a certificate from the Commission, and for not paying the unsuspended portion of the penalty. The Commission has not yet received payment in the amount of \$10,000 or any portion thereof.

This is to notify you that the Commission intends to forward your outstanding debt to a collection agency for collection. You likely will incur additional expenses and fees, including costs of collection, attorney's fees, and interest. These expenses and fees will be added to your outstanding \$10,000 balance.
