**BILL OF SALE**

**KNOW ALL MEN BY THESE PRESENTS:** That Columbia Basin, L.L.C., a Washington limited liability company ("Seller"), for and in consideration of the sum of TWENTY THOUSAND AND NO/100 DOLLARS (\$20,000.00) paid to Seller by Basin Disposal, Inc., a Washington corporation ("Buyer"), the receipt and adequacy of which are hereby acknowledged, hereby sells and delivers unto Buyer all of the personal property (the "Assets") described on Exhibit A attached hereto and incorporated herein by this reference.

Seller has the right and authority to sell, assign, transfer and deliver the Assets to Buyer.

SELLER AND BUYER HEREIN AGREE AS FOLLOWS IN REGARD TO THE AGREED DISCLAIMER OF WARRANTIES:

(i) BUYER ACKNOWLEDGES THAT BUYER HAS FULLY INSPECTED THE PHYSICAL ASSETS ALL OF WHICH CONSTITUTE GOODS, TO BUYER'S SATISFACTION, AND THE ASSETS ARE THOSE ASSETS AS LISTED IN SCHEDULE A ATTACHED HERETO.

(ii) BUYER UNDERSTANDS AND AGREES THAT BUYER IS BUYING THE ASSETS LISTED IN THE ATTACHED SCHEDULES "WHERE IS", "AS IS", AND WITH ALL FAULTS OF ANY KIND OR NATURE WHATSOEVER, EXCEPTING THAT SELLER WARRANTS THAT SELLER HAS GOOD AND MARKETABLE TITLE TO EACH OF THE ASSETS AND THAT THE ASSETS ARE FREE OF ANY LIEN, SECURITY INTEREST, OR ANY CLAIM OF ANY UNPAID OBLIGATIONS, OR UNPAID TAXES OR ASSESSMENTS;

(iii) SELLER DISCLAIMS ANY WARRANTY OF MERCHANTABILITY EXPRESS OR IMPLIED, OR FITNESS, OR FITNESS FOR A PARTICULAR PURPOSE, EXPRESS OR IMPLIED, OF ANY KIND OR NATURE WHATSOEVER, AS TO ANY OF THE ASSETS BEING SOLD PURSUANT TO THIS BILL OF SALE;

(iv) SELLER DISCLAIMS ANY WARRANTY OF SUITABILITY, OR SUITABILITY FOR A PARTICULAR PURPOSE, EXPRESS OR IMPLIED AS TO ANY OF THE ASSETS BEING SOLD PURSUANT TO THIS BILL OF SALE;

(v) THE ASSETS ARE BEING SOLD SOLELY FOR COMMERCIAL PURPOSES, AND ARE NOT BEING SOLD OR BOUGHT, OR INTENDED FOR PERSONAL, FAMILY, OR HOUSEHOLD USE OF ANY KIND OR NATURE WHATSOEVER;

(vi) BUT FOR BUYER'S AGREEMENT TO BUY THE ASSETS SUBJECT TO THIS DISCLAIMER OF WARRANTIES, SELLER WOULD NOT SELL THE ASSETS TO THE BUYER;

(viii) BUYER'S REMEDY FOR ANY BREACH OF WARRANTY BY SELLER IS HEREIN LIMITED TO THE AGREED PURCHASE PRICE PAID FOR THE SUBJECT ASSETS SOLD, OR AT THE ELECTION OF THE SELLER REPAIR OR REPLACEMENT, AND BUYER HEREIN ACKNOWLEDGES THAT BUYER SHALL NOT BE ENTITLED TO ANY CONSEQUENTIAL DAMAGES OR PUNITIVE DAMAGES OR ANY OTHER FORM OF DAMAGES OF ANY KIND OR NATURE WHATSOEVER.


