

NOTICE OF PUBLIC HEARING REQUESTED CHANGES TO PUGET SOUND PILOTS

On June 29, 2022, Puget Sound Pilots ("PSP") filed a general rate case with the Washington Utilities and Transportation Commission ("UTC") requesting an increase in pilotage rates. The UTC has authority to approve rates that may be higher or lower than PSP's request. The UTC is examining the proposed rates; the examination can take up to 11 months. The UTC has indicated that it will likely enter a final order regarding the proposed increase in pilotage rates by July 10, 2023.

PSP has requested the following:

- An increase of 35.6 percent in pilotage rates.
- An increase of 32.43 percent in target distributable net income per pilot.
- To transition the PSP pension plan from a "pay as you go" system to a fully funded system.
- To incorporate multiple "automatic adjusters" in PSP's tariff that will automatically modify pilotage rates in response to certain contingencies including, for example, an increase or decrease in the number of pilots.
