5 **Q. Please state your name and business address.**

6 A. My name is Stephen J. King and my business address is 355 110th Ave. NE,
7 Bellevue, Washington 98004.

8 **Q. By whom are you employed and in what capacity?**

9 A. I am employed by Puget Sound Energy (“PSE”) as Director, Controller and
10 Principal Accounting Officer. I have been employed by PSE since August 2017.

11 **Q. What are your duties as Director, Controller and Principal Accounting**
12 **Officer of PSE?**

13 A. I am responsible for Puget Energy’s and PSE’s annual and quarterly financial
14 statements. I ensure that they are presented in conformity with generally accepted
15 accounting principles (“GAAP”) and that they present fairly, in all material
16 respects, the financial position of the companies and the results of their
17 operations. I also am responsible for PSE’s annual and quarterly Federal Energy
18 Regulatory Commission (“FERC”) reports, presented in conformity with the
19 FERC Uniform System of Accounts. I establish, monitor and enforce financial
20 policies and internal controls to ensure financial information is complete, accurate

1 and in compliance with accounting standards when filed with external parties, the
2 Securities and Exchange Commission (“SEC”) and FERC.

3 **Q. Briefly describe your education and relevant employment experience.**

4 A. I hold a Bachelor of Business Administration degree in Accounting and Finance
5 from Ohio University and am a Certified Public Accountant. I have over 12 years
6 of utility experience, primarily as an external auditor for publicly-owned utilities
7 that provide electric and natural gas services.

8 Prior to joining PSE in 2017, I was employed by PricewaterhouseCoopers LLP.
9 (“PwC”), a globally recognized professional services firm, from September 2007
10 to August 2017. I provided assurance and consulting services on behalf of PwC
11 in a wide variety of areas, including
