1 On June 30, 2006, the Washington Utilities and Transportation Commission (Commission) assessed a penalty in the amount of \$100 against Parkland Water System, Inc. (Parkland Water) for one violation of WAC 480-110-505.

2 On July 6, 2006, Parkland Water filed an Application for Mitigation and a Request for Hearing.

3 On July 26, 2006, Commission Staff filed its response to Parkland Water’s Application for Mitigation and Request For Hearing.

4 Pursuant to RCW 34.05.482 and WAC 480-07-610, the Commission determines that a brief adjudicative proceeding is appropriate for resolving the issues that are raised in the applications for mitigation.
