NOTICE OF OPPORTUNITY TO FILE WRITTEN COMMENTS (Due by April 20, 2007)

Re: Rules to implement the Energy Independence Act
Docket UE-061895

TO ALL INTERESTED PERSONS:

On March 26, 2007, the Washington Utilities and Transportation Commission (Commission) held a stakeholder workshop concerning initial draft rules to implement the Energy Independence Act, RCW 19.285. Due to the comments received at the workshop, it is apparent that the initial draft rules would benefit from additional public comment. The initial draft rules are available for inspection on the Commission's web site at http://www.wutc.wa.gov/061895. The Commission will send a paper copy of the initial draft rules or will send the proposal via electronic mail, if requested.

The Commission is considering how best to address the regulatory issues associated with implementing the Energy Independence Act. To that end, the Commission specifically solicits respondents to identify, and to assign to one of three categories, all regulatory issues the respondent desires the Commission to consider in this rulemaking. The three categories are:

- 1. Regulatory issues best dealt with in adjudications or other fact specific decision making processes;
- 2. Regulatory issues best dealt with in rules but that do not need immediate Commission action; and
- 3. Regulatory issues for which near term Commission action is needed so that utilities may properly implement the statute.

The Commission requests that interested parties compare items included in this third category – regulatory issues needing immediate resolution – with the initial draft rules. The Commission requests the commenter to provide suggested rule modifications to ensure that the initial draft rules address all the regulatory issues included in the third category. The Commission also seeks suggested language changes to eliminate from the initial draft rules any regulatory issue the respondent would assign to the first or second category. Finally, the Commission requests that interested parties review and comment on the draft processes that a utility would follow to establish a conservation target and to demonstrate compliance with the conservation and renewable resource targets.

The rulemaking schedule has been revised to reflect this additional round of comments. The revised schedule is as follows:
