On September 5, 2018, Puget Sound Energy (PSE or Company), jointly with Alberta Investment Management Corporation, British Columbia Investment Management Corporation, OMERS Administration Corporation, and PGGM Vermogensbeheer B.V., filed with the Washington Utilities and Transportation Commission (Commission) an application for approval to sell non-controlling interest in Puget Holdings LLC (PSE's Application).
