Q1 2022 Quarterly PCAM Report (January 2022 to March 2022)**

PacifiCorp dba Pacific Power and Light Company (PacifiCorp or Company) submits its Q1 2022 Power Cost Adjustment Mechanism (PCAM) quarterly report in accordance with Order 01 in Docket UE-210447 dated September 30, 2021. Specifically, Ordering Paragraph 3 requires PacifiCorp to “provide quarterly reports on PacifiCorp d/b/a Pacific Power & Light Company’s PCAM deferral balance beginning December 15, 2021”.

The allocation factors used in this Q1 2022 report for calendar year 2022 are preliminary and are currently based on the 12 months ending March 2022. Allocation factors for calendar year 2022 have not yet been finalized. The Company’s annual PCAM filing, due to be filed with the Washington Utilities and Transportation Commission in June 2023, will reflect final calendar year 2022 allocation factors.

Confidential work papers are provided in accordance with WAC 480-07-160. The confidential work papers include valuable commercial information, specifically confidential cost and financial information associated with loads and pricing. Disclosure of such information would harm PacifiCorp by an unfair competitive disadvantage.
