I, CARL A. GIPSON, declare and state:

1. I am over the age of 18, and competent to testify to the matters set forth herein. I have personal knowledge of the matters testified to below, or am so testifying based on my review of official company records.
2. I am employed by Frontier Communications Northwest Inc. ("Frontier") as the Manager – Government Affairs. In that capacity, I am involved with and have knowledge of the efforts made by Frontier to notify customers and other interested parties of the Washington Utilities and Transportation Commission's ("Commission") Final Order 06 related to Frontier's petition in UT-121994.
3. On or about August 13, 2013, Frontier began distributing a Notice of Commission Decision printed on all bills sent to customers within the State of Washington (the "Bill Message"). Frontier estimates that 315,000 customers will receive the Bill Message. A copy of the Bill Message is attached as Exhibit A.
4. Frontier issues bills to its customers in 10 billing cycles, so as to be responsive to customers who have requested bills on or by specific dates, as well as more efficiently using its billing facilities by spreading out that activity. Thus, Frontier issues bills to Washington customers approximately every three days. The last regular bills to receive the Bill Message will be issued on or about September 15, 2013. All Washington customers will receive a copy of the bill message within normal mail delivery times after that date.
5. I make out this declaration so as to satisfy the requirements of WAC 480-120-198 and terms of the Multiparty Settlement Agreement in the docket.
