b. For each directory identified in (a), provide the geographic areas served by such directory, the names of the "multiple exchange carriers" whose listings are contained therein, the quantity of listings for each such exchange carrier, the total number of pages in each such directory during each of the years 1998-2003 or as available, the circulation of each such directory during each of the years 1998-2003 or as available, the number of years that the directory has been in continuous publication, and the total Washington State advertising revenues for each such directory during each of the years 1998-2003 or as available.

RESPONSE:

As explained in Qwest's Response to WUTC Set 2, Data Request No. 006I, Qwest does not have a complete list of "each and every one" of the directory publishers or the directories each publisher publishes in Washington. The 23 Washington Primary directories that Dex publishes on behalf of its Publishing Agreement with Qwest are listed below with the number of carriers that have listings included in the Dex directory. Also provided are the number of publishers and the number of directories that Qwest has identified in the same geographic area. The publishers and directories are not necessarily complete.
