- On July 22, 2013, the Washington Utilities and Transportation Commission (Commission) entered Order 06, Final Order Approving Settlement Agreements with Conditions and Classifying Services as Competitive (Order 06).
- Frontier Communications Northwest Inc. (Frontier) made two tariff revision filings in compliance with Order 06: (1) Advice No. 3338 on August 8, 2013; and (2) Advice No. 3339 on August 12, 2013. On August 28, 2013, Frontier made two replacement tariff filings to correct errors in its initial filings. Collectively, these filings reflect classification of certain telecommunications services as competitive. Frontier summarized the filings as follows:
 - a. Add the proposed language on the Title Sheet in Facilities for Intrastate Access Tariff, WN U-16, to provide that "Services provided in this tariff are available to all Wholesale and Retail customers";
 - b. Transfer and mirror the complete Facilities for Intrastate Access Tariff, WN U-16, into a new Service Catalog and modify the Title Sheet to provide that "Services provided in this Service Catalog are only available to certified Long Distance carriers and CLEC's";

- c. Reissue the General and Local Exchange Tariff, WN U-17, with appropriate section numbering, identifying all tariff sheets as "Original" and removing Competitive Retail Services. Competitive Retail Services are included in a new Service Catalog;
- d. Withdraw Tariff WN U-18, the Company's Network Interconnection Access Service tariff, and replace it with a new Network Interconnection Access Service, Service Catalog;
- e. Withdraw Tariff WN U-20, the Company's Local Network Access Service, Collocation Service tariff, and replace it with a new Local Network Access Service Collocation Service, Service Catalog;
- f. Withdraw Tariff WN U-21, the Company's Unbundled Network Elements tariff, and replace it with a new Unbundled Network Elements, Service Catalog;
- g. Withdraw Tariff WN U-22, the Company's Resale Local Exchange Services tariff and replace it with a new Resale Local Exchange Services, Service Catalog;
- h. Withdraw Tariff WN U-23, the Company's Advanced Data Services tariff, and replace it with a new Advanced Data Services, LD & CLEC Service Catalog; and
- i. Withdraw Tariff WN U-23, the Company's Advanced Data Services tariff, and replace it with a new Advanced Data Services, Wholesale & Retail Service Catalog.
- No party filed comments on the Compliance Filings. Commission Staff examined the filings and has determined they are in compliance with Order 06. Accordingly, Staff recommends that the Commission accept the filings.
- The Commission agrees with Staff's recommendation and approves the Compliance Filings.

ORDER

THE COMMISSION ORDERS that the Commission approves Frontier Communications Northwest Inc. Advice No. 3338 filed on August 8, 2013 and Advice No. 3339 filed on August 12, 2013, both as amended on August 28, 2013, as being in compliance with Order 06. The revised tariffs are effective as of the date of this Order.
