This request is being made in the context of the filing to increase pilotage rates filed with the Washington Utilities and Transportation Commission by the Puget Sound Pilots. On behalf of Pacific Merchant Shipping Association, I am writing to request copies of the records described below to assist in the proceedings before the Commission.

4. Records showing the number of individuals on the trainee waiting list by month (or if not available, by year) since the 2008 marine pilot exam.
5. Records showing the number of pilot trainees engaged in the pilot training program by month (or if not available, by year) since the 2008 marine pilot exam.
6. All complaints served on the Board of Pilotage Commissioners by pilot applicants or trainees since the 1990 marine pilot exam.
7. All documents regarding retirement plans or disbursements made by Puget Sound Pilots under WAC 363-116-315 that Puget Sound Pilots submitted to the Board of Pilotage Commissioners from 2015 to present.


