**NOTICE CONCERNING CONFIDENTIALITY AGREEMENTS
FILED WITH THE COMMISSION**

RE: In the Matter of the Petition of Qwest Corporation to Initiate a Mass-Market Switching and Dedicated Transport Case Pursuant to the Triennial Review Order, Docket No. UT-033044.

On December 5, 2003, the Commission entered Order No. 08, Order Granting in Part Qwest's Motion to Modify Order No. 02, Protective Order; Directing Withdrawal of Exhibit C Filings. In response to that order, Qwest filed a letter with the Commission on December 16, 2003, identifying three in-house experts and 12 outside experts who have executed Exhibit Cs to the Protective Order. Qwest plans to identify two additional in-house expert witnesses and submit executed Exhibit Cs .
